International Seminar on





Socio-economic Impact of Rohingya Crisis on Asian Countries--Laws, Policies and Challenges"

"It affects and involves us all, and what it needs is understanding, compassion and political will to come together and find real answers for the refugee plight. This has become a defining challenge of our times"

— Filippo Grandi (United Nations High Commissioner for Refugees)

The Rohingya crisis is rooted in the contentious issue of their nationality and citizenship. The Burma Citizenship Act of 1982 provided citizenship to anybody living in Burma who could prove that they had lived there before 1823, the year of the first British military war against Myanmar and a subsequent influx of people from India and China. As transnational relationships were frequent for many families of different ethnic groups and there was rarely paperwork to support whether a person had strong roots in Myanmar, the law was extremely troublesome. The 1982 citizenship law recognizes only eight ethnic groups as 'citizens' (Kachin, Kayah, Kayin, Chin, Mon, Bamar, Rakhine, and Shan), denying a total of 135 ethnic groups in Myanmar, along with Rohingyas, the rights and privileges available to citizens. The Tatmadaw (Myanmar Army) has always rejected Rohingya calls for citizenship, and their leaders have argued that the current conflict has been fueled because the Rohingyas demanded citizenship. But according to historical reports, Rakhine and Rohingya people have coexisted in Myanmar's (formerly Burma's) Arakan area for many years. The latest military coup has worsened the situation for the Rohingya people. The issue regarding citizenship has not only led to the Rohingyas fleeing regularly but has also exacerbated hostile local conditions, reducing the possibility of their return to their homeland. On paper, from August 2017 till date, approximately 745,000 Rohingyas were forced to escape their homes in Myanmar's Rakhine State due to armed attacks, widespread violence, and grave human rights violations. There were two unsuccessful attempts to persuade several thousand refugees to return, in 2018 and 2019, but those chosen were unwilling to participate in the process without sufficient assurances from the Myanmar government about their security, access to citizenship, and employment opportunities after their return. Partly in response to the violence, Bangladesh has imposed stricter restrictions on refugees, including restricting their ability to leave the camps, their access to the Internet, and their ability to communicate with local people. Others paid large sums to traffickers to embark on perilous boat trips to Malaysia, the secondlargest Rohingya refugee population after Bangladesh, while others attempted to travel to Indonesia.

Nearly 30,000 Rohingya have also moved to Bhasan Char, a muddy island in the Bay of Bengal that the Bangladeshi government has spent hundreds of millions of dollars developing specifically to host up to 100,000 refugees. The Bangladeshi government and the UN high commissioner for refugees signed a memorandum of understanding in October 2021 on behalf of UN organizations working on the Rohingya refugee response. When the first refugees landed there, suspicions of forcible relocations surfaced. The main reason for those who do decide to













transfer to Bhasan Char is probably to escape the deteriorating conditions in the Cox's Bazar camps. The Bangladeshi government's determination to move forward with the relocation of Rohingya to Bhasan Char shows a hardening of its stance toward the refugee population. Bangladesh made it plain from the start that, while having opened its borders to the desperate refugees in 2017, it would not permit them to remain there indefinitely and that, to host the Rohingya and assist their return to Myanmar, it would need international cooperation. The Bangladeshi people are currently unhappy and becoming impatient with the lack of advancement on repatriation. Public pressure on the Bangladeshi government to take a stronger approach has increased as a result of the surge in crime and violence in and around the camps. Dhaka is making life increasingly difficult for the refugees as it grows impatient. These limitations have sparked worries that the Bangladeshi government is trying to force refugees to move to Bhasan Char or, at the very least, return to Myanmar. Since the coup, the Rohingya have continued to be the target of discriminatory state policies. The military dictatorship has increased travel restrictions in some places, and the country's economic collapse over the previous 18 months has made their situation even worse. The situation is still dire for the 600,000 Rohingya people of Myanmar, almost all of whom reside in Rakhine State, but there are at least some indications that public perceptions of them are changing. The military's control of Myanmar makes repatriation appear impossible, but it's still necessary to make as much progress as possible, so Bangladesh will need to keep talking to the junta about it. By collaborating with counterparts in Myanmar civil society and the NUG, Bangladesh's very active civil society, which includes its universities, think tanks, and NGOs should do its lot to significantly impact policy and public sentiment toward the Rohingya in Myanmar. Due to the poor chances for returning home and the impossibility of integrating into Bangladeshi society given both public sentiment toward the Rohingya and the massive number of refugees, it appears progressively clear that third-country transportation ought to be a part of the spoken communication concerning sturdy solutions for this population. Dhaka has antecedently resisted this concept, saying that the chance of transportation would encourage additional Rohingya to cross the border into Bangladesh, which might ease the pressure on Myanmar to take back refugees. The time might be right for Bangladesh to review its policy and for foreign governments, notably within the West but also in Asia, to make it clear they can support Dhaka by accepting some refugees for voluntary transportation. At the same time, alternative countries hosting massive Rohingya populations, such as Malaya, the Republic of India, and Saudi Arabia, ought to reverse a worrying trend toward larger restrictions and threats to banish them to either Myanmar or Bangladesh. Although the Rohingya exodus was seen as a heavy humanitarian disaster, the international community did not exert pressure on the Myanmar government to alter its stance, permitting the government to point out no sign of bending in the face of the community's suffering.

At this point, Jyotirmoy School of Law feels it is significant to address these complex issues through a platform. Hence, this seminar will mainly focus on social, economic and political issues relating to the Rohingiya crisis, its impacts on Asia and its geopolitics as well as the laws, policies of various countries of our continent along with the contemporary challenges like the 'security concerns for the host nations'.













Sub Themes

- 1. Status of Refugees under International Law and role of U.N. & its agencies in addressing the Rohingya crisis.
- 2. Socio-economic and Legal challenges concerning Rohingya Refugees.
- 3. Security concerns for the host nations.
- 4. Scope and possibility of Asylum and Repatriation.
- 5. Necessity of a sustainable substantive policy in catering to the crisis of Rohingya Refugees.

Paper Presentation

We invite contributions for presentation from academicians, legal professionals, researchers, activists and students of Law or of any other fields. Potential paper presenters are expected to submit the abstracts of their papers along with a cover letter clearly mentioning the full name designation (Maximum 250 words) by 21st November, 2022 and full papers (Maximum 3000 words including footnotes) on the above mentioned topic must be sent on or before 23rd November, 2022 by e-mail to jslseminar2022@gmail.com All the papers must be typed in MS WORD file (Font: Times New Roman, Size: 12pt., Spacing: 1.5, Margin: I inch on all side, References: in alphabetical order).

Information about the acceptance or otherwise will be sent by e-mail only. In addition, a hard copy of the above is to be sent by post to the contact address given below. Presentation shall be dependent on the scrutiny by the committee. Papers selected by the committee only can be allowed to be presented in the seminar. The selected persons will be eligible to fill-up the registration forms. Certificates shall be issued to all participants.

Publication:

Selected research papers presented during the seminar will be published as an edited book with eye ISBN number. However, the decision of the editorial board will be final for selection of the papers to the published.

DEBATE





<u>Preparation Time –</u>

- **20 minutes** will be permitted for the preparation of a pre-announced topic before the beginning of the debate competition and **35 minutes** will be allowed for preparation after announcement of an impromptu topic of the debate competition.
- Debaters may use personally prepared research briefs and published material (dictionaries, periodicals, briefing papers, books, etc.) during preparation time only. Debaters may consult with the assigned coaches in case of any query.
- Debaters may use electronic resources (computer, PDA, mobile phone, etc.) or access the Internet during the preparation time only. Published and preprepared documents (those documents organized prior to the preparation time period) cannot be used during the debate.
- Debaters may use notes that they prepare during preparation time; they may also use notes they have prepared during the debate (e.g., notes of speakers in the debate, also known as a "flowsheet.") In other words, debaters must transcribe any advanced prepared notes or published information for use during the debate.
- Use of mobile phone will be allowed.
- Students must be present at the assigned hall on appropriate time and must be ready to begin for their contemplation at the end of preparation time.
- Participants will not be allowed any extra time for their preparation or any additional walking time to the assigned hall to begin the debate.
- Preparation time of 20 minutes or 30 minutes, as the case may be, is the total and the maximum of amount of time from the announcement of the topic for debate to the beginning of the opening speech of a debate.

Order of Speech & Speakers Responsibilities -

- > There must be 3 participants from each team.
- > Each debater gives one speech at a time.

Order of Speeches -

- *First proposition constructive* should be allowed 6 minutes; this speaker makes a case for the motion for debate, providing a proof of the topic with three or four major points.
- *First opposition constructive* will be allowed 6 minutes. This speaker makes several arguments against the proposition team's case and refutes the proposition's major points.
- Second proposition constructive will be allowed 6minutes.
 This speaker should rebuild and extend upon the proposition's case. This means
 that this speaker must defend and amplify the original proposition points and
 refute the opposition's major arguments.
- Second opposition constructive will be allowed 6 minutes.
 This speaker amplifies the opposition arguments against the case, providing new information about why the opposition team should win the debate.













This speaker should answer the proposition's answers to the opposition team's original arguments. This speaker may split summarization of the debate with the opposition rebuttal lists.

<u>Proposition rebuttal</u> - 5 minutes; this speaker should summarize the issues in the debate and explain why, even with the opposition's arguments, the proposition teams should win the debate. This speaker accounts for all remaining major points of the opposition team.

<u>Opposition rebuttal</u> – 5 minutes; this speaker must put the debate together and explain why, given one or more arguments in the debate, the opposition team should win the debate. This speaker accounts for or refutes the proposition's major points.

- No alteration of participants will be allowed on the final day.
- No request from participants will be entertained in order to attend a separate event which may clash with this event.

MOOT COURT

STATEMENT OF FACT

- 1. Ayesha a girl hailing from Kerala has been working as a domestic help in a household of Delhi for almost 2yrs. She came to the city with her father in the year 2018 at the age of 14yrs.
- 2. Mr. Asif aged about 49 yrs is head of the household. He is having textile business. His two sons help him with his business. The elder one is Amir aged about 25 yrs and younger one is Aman aged about 21 yrs. Their mother Shaira is a 43 yrs old house wife.
- 3. Ayesha is responsible for mostly housekeeping along with serving breakfast and other meals to the family members.
- 4. During last 6 months Ayesha and Aman grew an intimate relationship. When the matter came to the knowledge of Aman's parents they scold Ayesha and threatened to throw her out of the house if she continues the relationship. But they continued meeting each other privately.
- 5. In the month of January 2020 Ayesha found out that she is pregnant. She informed Aman about the situation. Aman comforted her with the assurity of marriage.
- 6. On 1st February 2020, the couple tied the knot. They did not disclose the fact from their parents. But it was revealed eventually. Reaction of parents from neither side was good.
- 7. Mr. Asif insulted Ayesha's father unjustly. Ayesha's father filed a police complaint in Kerala on the ground that Ayesha is below 18yrs and Aman's parents forced her to marry their son.
- 8. He also accused Aman for raping his daughter.
- 9. Warrant was issued against Aman.
- 10. In this circumstances, the couple moved to Delhi High Court with the hope of getting justice.

Issues

- 1. Whether the marriage is valid?
- 2. Whether rape was committed?









Rules and Regulations:





Eligibility:

All students of Universities, Colleges and Institutions imparting Legal education on a regular basis that leads to a Bachelors degree in law (LL.B / BL) or Masters in law (LL.M / ML) are eligible to participate in the Moot Court competition.

> Team Composition:

- Each participating University/College/Institution shall nominate only one team consisting of **three** student members.
- Each Team shall consist of two speakers and one researcher; the Organizer will assign each team with a **Team code** after the registration.

Interpretation of Rules:

- > During the **Rounds**, each Team shall argue once as Petitioner / Respondent.
- > The marks of the written memorial will not be taken into consideration for the selection of the Teams for the semi-final and final round(s) of the competition.
- > Prizes for Best Advocate and Best Memorial will be awarded. The Best Advocate will be awarded to the one, judged by the organizing committee, who has performed best during her/his oral presentations and the Best Memorial prize will be awarded to the team who has prepared the best Memorial.
- >The participants must stick to the rules. The organizers hold the right to disqualify teams for deviating from these mentioned rules.
- > The Organizers will resolve any contingencies that may arise. The decision taken by the Organizers shall be final.
- >These Rules are not exhaustive.

Memorials:

- > Each participating Team shall prepare both memorials in English.
- > All teams are to submit their copies to the organizers before the event.
- > Each Team must submit 2 hard copies of the Written Memorial for the Petitioner and 2 copies of Written Memorial for the Respondent.
- > During oral presentations, the participating Teams should keep copies of their memorials for their personal use. Exact soft copy of the memorials must be submitted not later than November 18, 2022 in the under mentioned email address. email id: jslmootcourt@gmail.com













Anonymity of Teams:

- > A team code will be allotted to the Participating Team(s) after the registration.
- > The Student Council shall not state the names of the teams, instead must use the code allotted during the oral rounds.
- > It is the responsibility of the Teams to ensure that the correct number of Copies of the memorials are submitted to the Organizers and acknowledgement obtained.
- > All memorials submitted must comply with the following general requirements and a team will attract negative marking for failure to keep within the limitation as described below:
- i. Memorials must be printed on A-4 paper with black ink. The Memorial shall preferably be spiral bound.
- ii. The font of the body of the Memorial must be **Times New Roman**, size 12, and the size of footnotes/ endnotes, if any, must not be less than size 10.
- iii. Each page must have a margin of at least 1.5 inch on all sides.
- iv. The Memorial should not exceed 15 typed pages and shall consist of the following parts:
- Cover Page: Should be coloured **Blue** for Petitioner, and **Red** for Respondent.
- Table of Contents.
- Index of Authorities.
- Statement of Jurisdiction.
- Statement of Facts.
- Statement of Issues
- Summary of Arguments.
- Written Pleadings.
- Praver.
- v. Relevant Annexure may be attached to the Memorial.
- vi. However, no team would be allowed to pass any material to the judges while presenting their oral arguments.

Oral Arguments:

- > The language of the Court shall be English.
- > Time allotted for arguments will be **10 minutes** for the **Petitioner** and **10 minutes** for the **Respondent**. There will be a negative marking after the minutes allotted. There will be a warning bell at the end of **8 minutes**.
- > Extra time will be allotted to respond to the questions posed by the judges.
- > Rebuttal will be allowed. There will be time allotted for rebuttals. Each team is allotted with 5 minutes for rebuttals.
- > If a Team scheduled to take part in a round does not appear for 10 minutes after the scheduled start of the round, **a walkover** shall be declared in favour of the team present.

Scoring Criteria:

- 1. Memorials: 30 marks
- 2. Appreciation of Facts and Evidence: 10 marks.
- 3. Reasoning of Application of Principles: 10 marks.













- 4. Use of Authorities and Precedents: 10 marks.
- 5. Response to questions and articulation: 10 marks.
- 6. Advocacy Skills (Argumenis, Framing of Ideas, Expressions and Articulation): 20 marks.
- 7. Court Craft and general impression: 10 marks.

Competition Rounds:

The Organizers will divide the participating teams into parts depending on the number of teams participating.

The competition shall consist of three rounds:

- (a) Preliminary Round;
- (b) Semi Final &;
- (c) Final

- The language for the extempore will be English.
- 5 minutes will be allotted to each participants (3 minutes to prepare and 2 minutes for speaking)
- A warning bell will ring at the **end of 1.5 minutes**.
- Time limit is to be strictly followed. No alterations will be allowed in any case.
- Topic will be provided on-spot. It will be done in the form of lottery.
- Participants must carry their own piece of paper and pen for preparation.
- Speech notes are not to be used by the contestant while presenting his/her speech.
- Sound round shall be conducted in of tie for winning/runners-up position.
- Decision of judge(s) will be final.
- All participants must to the report the concerned committee member 30 minutes prior to the scheduled time of the competition.
- No requests will be entertained as to attend a different event, which may clash with this event.

PAINTING

- Students are required to bring their own materials for painting.
- During registration, the participants must submit their materials of painting & get them officially stamped.
- Abstract painting will not be allowed.
- Only one entry per participant will be accepted.
- The organizers will provide Art paper.
- Participants are required to register their names by e-mail 10 days prior to the competition.
- The participants will be given a time of one and half hours to complete their work.
- All art works must be original work of the participant.
- If any participant is caught cheating, the invigilator will cancel his/her painting.

- "Hindi Solo" includes all types of Hindi Songs e.g. Bollywood/Classical/Ghazals etc.

- Any type of obscenity is strictly prohibited.
- No alteration of participants will be allowed on the final day.

- Decision of the Judges will be final.

TUG OF WAR

- Only one team can participate from each college.
- 8 teams will be registered on first come, first served basis.
- Each team shall consist of 8 players.

HIT THE WICKET





- 2 teams can participate from each college.
- A team should consist of 3 players.
- All the members of the team will be given 3 chances to hit the wicket.
- The teams that hit the most number of times will qualify to the next round.
- Subsequently, players will be eliminated on each round.
- An individual with highest hits at the final round will be declared as the winner.
- No alteration of participants will be allowed on the final day.
- No requests will be entertained as to attend a different event, which may clash with this event.

CARROM

- It will be played in doubles.
- Either the doubles team can be mixed or boys double or girls double.
- 2 teams can participate from each college.
- 8 teams will be taken.
- A match will be played for 29 points or 4 games whichever comes early.
- The selection of sides and strike will be decided by means of a toss.
- The tournament will be played on elimination basis.
- At the end of a game, each carrom man left on the board for the opponent will fetch the winning team 1 point. If the winning team covered the queen during the course of the game, it will fetch an additional of 3 points. This shall however continue until a team reaches 24 points.

TREASURE HUNT


- Number of teams: Maximum 2 teams per college (4 players per team).
