Part-I and Part-II examinations, 2020 will be held **ONLINE** and it will commence on & from 7.7.2021 as per the schedule notified by the University of Calcutta dated-14.6.2021. The details of the conduct of the said **ONLINE** Examination (to be commenced from 7.7.2021) are as follows:

- 1. The question papers for the online examination will be sent to the E-mail id of each student of Department of Law and colleges may send the question papers to students by e-mail or upload the same on their respective college website, before the starting of the examination on the scheduled dates of examination.
- 2. The duration of each examination is four hours.
- 4. All examinees should submit the answer script only through e-mail within 30 minutes after writing the exams. E-mail IDs for sending answer script will be notified shortly by the respective college/Department.
- 5. Answers may be handwritten or be typed.
- 6. On the front page of the Answer Script, the students have to write:
 - (i) The university Roll Number and Registration Number.
 - (ii) Name of the Examination (2 year LL.M. Part..... examinations, 2020).
 - (iii) Name of the Group, Subject and Paper Number.
 - (iv) Date of Examination.
 - (v) The university Roll Number must be written on each page of the answer script.
 - (vi) Each page of the answer script must be numbered like 1.2.3...... So on.
- 7. Each page of the answer script must be scanned one-by-one according to page number and must be sent as a single PDF file for the entire answer script, preferably within 15 MB.
- 8. The name of the PDF file will be the University Roll number.
- 9. The subject of Email-id while sending the Answer Script by the student is the University Roll, Part and Paper Number.
- 10. Students must not write their names in Answer Scripts.
- 11. Each student must have a valid e-mail id to submit the answer script.

Due care and attention must be taken by the examinees while writing the University Roll Number.
