## **NOTICE**

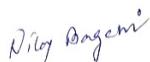

It is one of the oldest law colleges in India. The 'Rastraguru' Surendranath Banerjea, the great patriot and educationalist found this prestigious institution. In 1882, the Presidency School, which formed the nucleus of the present Institution, was handed over to Sir Surendranath Banerjea on 1 st January 1884. He raised it to the status of a college affiliated to the F.A. standard and named it "The Presidency Institution". Within a year the institution was converted into a full fledged, first grade college under the name "Ripon College". Its activity was further extended through the opening of the Post-Graduate Department of Law in 1884, which was later affiliated to the Calcutta University in the year 1885, as an independent professional college. But after the attainment of independence, the golden cause to which Sir Surendranath dedicated his entire life, the name of the college was altered to Surendranath College. This esteemed Law College is now regarded as one of the oldest law colleges of the country. Presently, this College imparts 5 Years B.A. LL.B course, 5 Years B.A. LL.B (Honours) Course and two Years LL.M Course.

## **About the course**

Surendranath Law College offers Online Certificate Course in Criminal Justice and Victimology.
