## OVERVIEW OF THE SCHOLARSHIPS

### KANYASHREE 2 (K2)

Kanyashree Prakalpa seeks to improve the status and wellbeing of girls, specifically those from socio-economically disadvantaged families through Conditional Cash Transfers. The schemes benefits are paid directly to bank accounts in the girl students' names. The scholarship is an intervention to incentivize girl students to achieve a better footing in both the economic and social spheres by continuing education for a longer period of time so that their education provides enhanced social and emotional development for better foundation in their adult lives. Through Kanyashree Prakalpa, it is expected that the practice of child marriage is completely eradicated, and women will attain their right to health, education and socio-economic equality.

K2 provides scholarship to girl students' (applicant), when applicant attains the age of 18 years to empower her through scholarship of one-time grant for forwarding steps towards education after higher secondary towards under graduation.

### ELIGIBILITY CRITERIA

One-Time Grant (K2) The Scheme assures a One-Time Grant of Rs.25,000/-to girls who fulfill the following eligibility criteria:

**KANYASHREE 3 (K3)**

Kanyashree (K3) is the extension version of the K2 which seeks to incentivize Girls Students (married/unmarried) pursuing Post Graduate courses in Science, Arts and Commerce stream from Universities of this State after obtaining Under Graduate Degree with 45% marks in aggregate from Institutions of this State. K-3 scholarship is not inculcated within Kanyashree Prakalpa portal rather it comes within Swami Vivekananda Merit-cum-Means Scholarship Portal. Therefore, eligible girl students may apply for scholarship through portal of Swami Vivekananda Merit-cum-Means Scholarship.

**ELIGIBILITY CRITERIA**

- Degree with 45% marks in aggregate from Institutions of this State.

- Applicants, willing to apply for K3 are required to fill up the authentication form to verify their existence in Kanyashree(K2) with the input fields Kanyashee(K2) Year of Application, Kanyashree ID, Applicant's Name, Applicant's Date of Birth, Father's Name, Mother's Name.
- Girls' students pursuing regular course of Post-graduation in Science/Arts/Commerce but do not have any Kanyashree(K2) ID should apply under Directorate of Public Instruction category. The criteria and benefits are same as Kanyashree(K3).
- For Renewal of existing beneficiaries, Online registration is not needed, rather they can login with their previous Applicant ID and Password to apply for renewal.

### **OASIS SCHOLARSHIP**

The Backward Classes Welfare Department and Tribal Development Department of the Government of West Bengal operates the **Oasis Scholarship Portal**, which serves scholarships available to students belonging to the SC, ST, and OBC categories in the state at the Pre and Post Matric stage. The OASIS portal provides a comprehensive list of pre- and post-matric scholarships for eligible students of certain reserved categories to ensure their continuation in academic domain bring them forward.

### **ELIGIBILITY CRITERIA**

Post-Matric Scholarship for SC/ST- To avail this scholarship, students must be enrolled in a post-secondary or post-matriculation degree and be a member of the Scheduled Caste/ST group. The total yearly income of the parents/guardians should not exceed INR 2.5 lakh.

Post-Matric Scholarship for OBC- To avail this scholarship, student must be a post-secondary applicant who falls into the OBC category. The family's/yearly guardian's income from all sources should not exceed INR 1 lakh.

- Caste Certificate (Online Verification from Oscar Portal)
- Copy of Marksheet of last examinations passed
- Fees receipt of the last admitted semester

These documents are needs to be submitted to the Block Office/ Sub-Division office / DWO Kolkata's office as applicable with the hard copy of application for verification.

## **AIKYASHREE SCHOLARSHIP**

To address the growing aspiration for education in the minority communities of the state, the Aikyashree scholarship scheme has been set up to extend financial support and encouragement to meritorious students from minority communities of West Bengal (Muslims, Christians, Sikhs, Buddhists, Parsis and Jains). The scholarships have been expertly conceived to support students from the minority communities right from the primary level. It encourages students to take up higher education and also enroll in technical & professional courses to increase skill levels and employability. The West Bengal Minority Development and Finance Corporation (WBMDFC) is the Nodal Organization for this scheme.

Aikyashree scholarship provides pre-matric level, Post Matric levels and the Merit-cum-Means scholarships for pursuing technical and professional courses. The scholarship offers wide support by covering admission and tuition fee, hostel and accommodation charges. Post-Matric scholarship is given to students pursuing Higher Secondary, ITI, Diploma, Graduation, Post Graduation, B.Ed. and Ph.D. in recognized institutions in West Bengal in regular mode.

## **ELIGIBILITY CRITERIA**

### **Post-Matric Scholarship**

- Applicant must be a domicile of West Bengal.
- Must be in School/Institution recognized by an educational Board/Council/University of the State/Central Government.
- Must have secured not less than 50 % marks or equivalent grade in the previous final examination
- The Annual family income of the applicant should not exceed Rs. 2 lakhs.
- Students studying in institute outside West Bengal will not be eligible for pre-matric or post metric scholarship.

### **Merit-cum-Means Scholarship**

- Applicant must be a domicile of West Bengal.
- Must have got admission in a technical/ professional course.
- Must have secured at least 50% marks in the last Higher Secondary/Graduation examination.
- Annual family income of the student should not be more than Rs. 2.5 lakh.
- The students who are residents of West Bengal but pursuing studies in listed institutions located outside West Bengal, as may be notified from time to time by the West Bengal Minorities' Development and Finance Corporation, are also eligible for applying.

**SWAMI VIVEKANANDA MERIT CUM MEANS SCHOLARSHIP**

The **SVMCM** scholarship provides financial assistance to meritorious students belonging to economically backward families at different levels of higher studies in the State of West Bengal. The scholarships are sanctioned to deserving students on merit-cum-means criteria.

The upper ceiling for family income has been fixed at Rs.2,50,000/- per annum. The payment is made by direct beneficiary transfer only for which the students must necessarily have a bank account.

**ELIGIBILITY CRITERIA**

- Candidates whose family income is not more than Rs. 2,50,000/- per annum will be judged according to their academic merit in the under noted manner.
- For UG - level:  
The minimum qualifying marks for being considered for award of scholarships will be 60% in aggregate, in the H.S. Examination conducted by the W.B. Council of H.S. Education/Madrasha Siksha Parishad. For the UG (Arts), UG (Commerce), UG (Science) separate merit lists will be prepared.

- For PG - level:

Candidates should be graduates securing at least 53% marks (55% marks for applicants under DTE) in the Honours subject at the graduation level. The marks obtained in Honours subject will be the only deciding criterion academically for award of the PG-level scholarships. Kanyashree recipients (K-2) (married/unmarried) pursuing Post Graduate courses in Science, Arts and Commerce stream from Universities of this State after obtaining Under Graduate Degree with 45% marks in aggregate from Institutions of this State will come under the aegis of this Scholarship Scheme. There is no need to submit Income Certificate and Income Affidavit in respect of Kanyashree students applying for K-3 scholarship under Swami Vivekananda Merit-cum-Means Scholarship Scheme.
